Locum Tenens Position Information and Compensation

Successful candidates will be paid on a per examination basis: \$1,100 per autopsy performed. Locum Tenens forensic pathologists will cover only routine, non-criminal autopsies. A daily on-duty staff pathologist will determine jurisdiction and level of examination for all case assignments at a morning briefing.

Experience and Training Requirements

- Doctor of Medicine (MD) or Doctor of Osteopathy (DO) or Bachelor of Medicine and Bachelor of Surgery (MBBS), and a current license to practice medicine in the state of Texas.
- Experience in forensic pathology, including the completion of an accredited fellowship in forensic pathology.
- Certification by the American Board of Pathology in forensic pathology, or board-eligible in forensic pathology if recent fellowship graduate.
